CORPORATION OF THE TOWN OF HAY RIVER**

**A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF HAY RIVER IN
THE NORTHWEST TERRITORIES FOR THE PROVISION OF AN AMBULANCE
SERVICE AND TO ESTABLISH FEES AND CHARGES FOR SERVICE**

PURSUANT to the Cities, Towns and Villages Act, S.N.W.T. 2003, c.22, section 70 and 72.

WHEREAS the Council of the Corporation of the Town of Hay River in the Northwest Territories is desirous of providing for the establishment and operation of an ambulance service and prescribing fees to be charged for ambulance service,

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF HAY RIVER, at a duly assembled meeting, enacts as follows:

1. Short Title
 - a. This by-law may be cited as the "Ambulance Service By-law".

2. Interpretation
In this by-law;
 - a. "Council" – means the Council of the Town of Hay River.

 - b. "Schedule" – means a schedule attached to and forming part of the by-law.

3. Ambulance Service
 - a. The Hay River Ambulance Service is operated by the Hay River Volunteer Fire Department, as a municipal service for the Town of Hay River.

 - b. The Town is hereby authorized if necessary, to enter into agreements with the Government of the Northwest Territories; it's designate or Health Board to provide ambulance service in and about Hay River.

 - c. The Town is also authorized if the Town so wishes, to enter into an agreement with another Community or agreements with other Communities for the provision of ambulance service to such Community or Communities, by the Town of Hay River.

4. Training
 - a. The Town will provide for the training of Ambulance Service Personnel and may specify minimum training levels for all personnel of the Hay River Ambulance Service.


5. Ambulance Fees for Service

- a. Fees for service provided by the Hay River Ambulance Service shall be charged and collected in accordance with Schedule "A" attached to and forming part of the by-law.

6. Repeal

- a. That upon third and final reading of this by-law, By-law 2232/PS/11 is hereby repealed.

Schedule "A"

Ambulance Service Fees

1. The following fees shall be payable for ambulance services provided by the Town of Hay River:

Ambulance calls within the municipal boundary of the Town of Hay River. (Any Resident)	\$500.00 (five hundred dollars) for each call.

Ambulance calls within the municipal boundary of the Town of Hay River. (Non-Hay River Resident)	\$700.00 (seven hundred dollars) for each call.

NOTE: There shall not be a charge to Hay River residents who are 65 (sixty five) years or older for ambulance calls within the municipal boundary of the Town of Hay River.

Medivac and medical transfers within the municipal boundary of the Town of Hay River.	\$1,650.00 (one thousand, six hundred and fifty dollars) for each call, plus \$75.00 per hour waiting time after the first hour.

Ambulance calls outside of the municipal boundary of the Town of Hay River. (Hay River Resident)	\$600.00 (six hundred dollars) for each call plus \$2.00 per each running kilometre.

Ambulance calls outside of the municipal boundary of the Town of Hay River. (Non Hay River Resident)	\$1,650.00 (sixteen hundred and fifty dollars) for each call plus \$2.00 per each running kilometre.
