SUBJECT: MUSEUM SOCIETY GRANT SUPPORT REQUEST

RECOMMENDATION:

THAT THE COUNCIL OF THE TOWN OF HAY RIVER deny the request received from the Hay River Museum Society for a 2019 grant from the Town of Hay River in the amount of \$5000.

BACKGROUND:

A grant request letter from the Hay River Museum Society (HRMS) was received from the Town of Hay River on May 2, 2019. Through the letter, the HRMS requested \$5000 to support work done at the Hay River Heritage Centre in 2019.

The HRMS indicates through their letter that the Town should support the grant for the following reasons:

1. They had 2600 visitors in 2018 and hosted approximately 20 events;
2. There are concerted efforts to upgrade and improve the services they provide to the town;
3. It is their twenty-year anniversary in 2020 and they are looking to increase visitors and their length of stay in the community through their programming.

The HRMS followed up their letter as a delegation at the Regular Council Meeting on June 25th, 2019. Further justification for the grant was provided that included an indication of unbudgeted cuts to their Federal funding for summer student wages.

The Town of Hay River primarily issues grants to community groups through its Community Enhancement Grant Program. This program is designed to support community organizations that are implementing a community event or enhancement. The deadline for submissions for the 2019 program was November 2018. The budget was fully expended to awarded recipients. Currently the Town of Hay River does not allocate funds for other grant requests.

BYLAW NO. 2375/LND/19
MUNICIPAL CORPORATION OF THE TOWN OF HAY RIVER

A BYLAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF HAY RIVER IN THE NORTHWEST TERRITORIES, TO ACQUIRE LAND.

WHEREAS pursuant to the Cities, Towns and Villages Act S.N.W.T., 2003, c.22 in force April 1, 2004, Section 53 (1) which states:

53 (1) A Municipal Corporation may, for a municipal purposes,

- (a) acquire real property;
- (b) use, hold or develop real property owned by the Municipal Corporation;
- (c) subdivide in accordance with the Planning Act, real property owned by the Municipal Corporation.

NOW THEREFORE BE IT RESOLVED THAT, the Council of the Town of Hay River in the Northwest Territories in regular meeting of Council duly assembled enacts as follows:

1. That the Municipal Corporation of the Town of Hay River lease the whole lot of Lot 872, Plan 506, Hay River, as per attached sketch, from the Commissioner of the Northwest Territories;
2. That the Town lease the said land for Municipal purposes for a new Sewage Lift Station;
3. That the Mayor or Deputy Mayor and the Senior Administrative Officer of the said Town of Hay River are hereby authorized to execute the lease documents.
4. This bylaw will take force and effect upon its final reading.

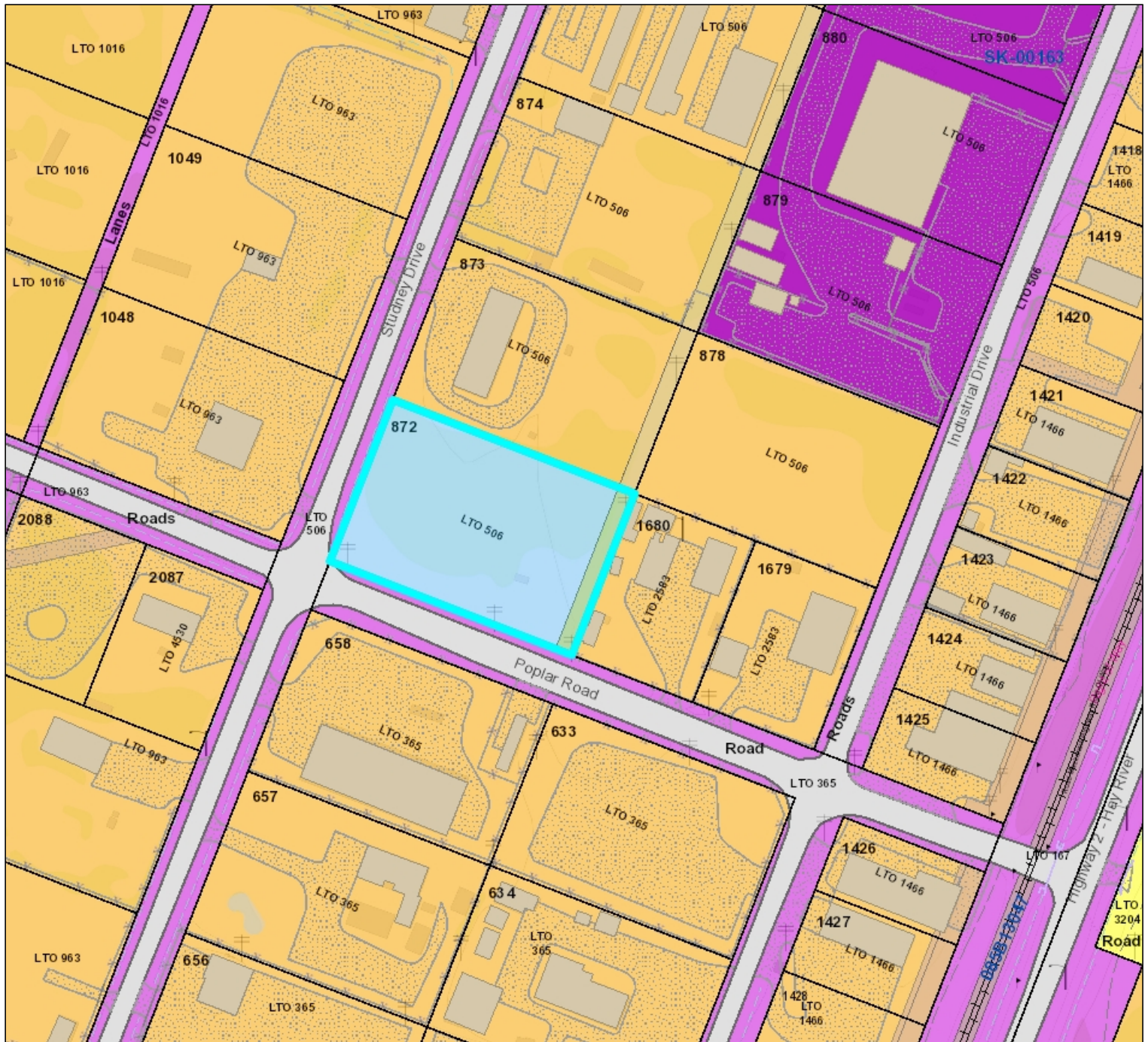
