Dear Mayor Mapes:

Designation of Cannabis Store; Restriction and Prohibition Options

As you are likely aware, the Legislature of the Northwest Territories has passed Bill 6, the *Cannabis Legalization and Regulation Implementation Act*. The enactment of Bill 6 allows the *Cannabis Products Act* to take effect the same day as the coming into force of the main provisions of the federal *Cannabis Act*. That date has not yet been determined, but we anticipate a date between mid-August and mid-September 2018.

Part 4 of the Northwest Territories *Cannabis Products Act* gives your community the option to hold a plebiscite to decide whether to prohibit or restrict cannabis sales and distribution. This option became available June 1, 2018 - the day Bill 6 received Assent - and it parallels the option available for prohibiting or restricting liquor.

The cannabis plebiscite option is available to a community until a cannabis store is designated for that community. If such a store is operating in a community, then it is no longer possible to hold a plebiscite with a question relating to the prohibition or restriction of the sale of cannabis at the cannabis store.

The *Cannabis Products Act* gives the Liquor Commission the authority to regulate the legal commercial cannabis market in the Northwest Territories and to sell cannabis through the existing liquor stores and mail order system. The Liquor Commission/liquor stores/mail order system ensures that Northwest Territories residents will have access to legal cannabis at prices that are competitive with the illegal market, so that we can curtail it and restrict youth access.

The Liquor Commission has recommended that I designate the Liquor Shop, at 1-100 Borden Drive, as a cannabis store, and I am therefore requesting your views in accordance with both subsection 6(1) of the *Cannabis Products Act* and subsection 35(2) of the *Liquor Act*, bearing in mind that once a cannabis store has been established there will be no further ability to prohibit or restrict sales in that store through the community control provisions of Part 4 of the *Cannabis Products Act*.

We anticipate that cannabis will be legalized in Canada by mid-August to mid-September 2018. Recognizing that a community may want to prohibit or restrict cannabis sales immediately, the Department of Finance, in collaboration with the Department of Justice, is committed to conducting a plebiscite within 30 days of the Minister of Finance receiving a resolution from a municipal or band council.

We ask for your council's views concerning the proposal to designate the Liquor Shop as a cannabis store, and further suggest that any resolutions requesting a plebiscite to prohibit or restrict cannabis sales be submitted to me as Minister of Finance before July 16, 2018 to provide the necessary time to conduct a plebiscite, and should it be approved, to reflect the results in regulations before legalization day.

The steps for this community prohibition/restriction process are:

- Step 1 a community government makes a resolution requesting that the Minister of Finance hold a plebiscite on the establishment of a cannabis restriction or prohibition system,
- Step 2 the Minister orders a plebiscite, sets the question, fixes the date, and appoints a returning officer,
- Step 3 the plebiscite is held,
- Step 4 assuming majority of voters approve the restriction or prohibition system, the Minister makes regulations to implement the system.

I look forward to hearing your community's intentions.

SUBJECT: Courtoreille Street redesign to one-way

RECOMMENDATION:

THAT THE COUNCIL OF THE TOWN OF HAY RIVER approve a budget of up to \$20,000 for Stantec to complete a redesign of Courtoreille Street roadworks project to turn Courtoreille Street into a one-way street with angle parking on both sides and widened sidewalks.

BACKGROUND:

The Town has been working to improve curb appeal in the downtown core to make the Town more attractive to visitors and residents. In discussing the Courtoreille Street project the concept was raised to make the street one-way with parking on both sides, wider sidewalks that would accommodate benches and potentially grated trees and planters.

There is little we can do in our downtown core to improve the look and feel of the area. Courtoreille as a one-way street would promote what is referred to as traffic calming and is proven to improve the character of a neighborhood.

The design engineers have confirmed that a one-way design would work for Courtoreille Street. The flow would be from Woodland to Capital Drive.

The Wright Centre, Jensen building and Drugstore building owners were consulted and support the concept in principle.

The current plan includes replacement of the existing sidewalk at Town's expense as they are already in place. The new design followed by discussion with the contractor would identify the incremental cost of widening the sidewalks on both sides of the street.
