

## **Public Notice**

Hay River Flood Update Saturday May 14, 2022 – 12:00pm

Residents of Hay River are to be advised that they should not return to the municipality at this time. Assessment is underway of impacted services. The Town will provide a detailed update within twenty-four hours. This update will include our phased reopening plan.

During this time, only individuals (recovery workers) who receive explicit approval through the checkpoint control will be permitted to enter the recovery zone.

Several areas of the Town are currently inaccessible, and water and sewer services are compromised. Boil water order is still in effect.

## If you are not directly involved with the disaster response process, do not return at this time.

As we are entering the recovery page, official updates will be provided once per day around noon, with special communications issued as needed.

Protective services are engaging in regular security patrols through neighborhoods.

Below will be an update by zone. It is critical that residents understand that their presence here is detrimental to our recovery effort. The sewer infrastructure system is interconnected, and wastewater will impact other zones. The Town has not confirmed the availability of essential services, including health, food, transportation etc.

## Vale Island Zone

- Still risks of more flooding in Lakeshore drive and West Channel zone.
- Access limited to rescue and recovery personnel. 450m of highway is compromised and currently closed. Crews are working on addressing stability issues today.
- Airport- gravel runway functional main strip not functional due to ice.
- No power services to old town/west channel. Crews will begin replacing downed poles this weekend. General assessment of condition has occurred.
- Numerous propane tanks displaced, some leaking. Some recovery action to be taken today in West Channel. Repairs to commence Monday.
- 553 area including Two Seasons/Castaways
  - Both lift stations now functional
  - Power on throughout excluding limited properties on Cranberry.
  - Two Seasons/Castaways no power, no road accessibility. Crews are working on water treatment plant road today.
- Area from McRorie Dr. to West Channel Bridge (east of Highway 2) including Downtown.
  - No sewer service available.

- o Riverview Dr., Gaetz Dr. impassible. No road access.
- Residents will not be permitted to return to this area until sewer services are restored.
- Power distribution service still available in this zone, excluding downtown transformers which are being assessed today.
- o Irma Miron trail/ Ravine filled with river and wastewater (storm surge). Pumps have been running to clear water. More pumps arriving today. Ultrapumps will be in town Sunday evening and commencing work then. It is critical that residents of this area understand that any wastewater added to this system is collecting in the ravine. Extra fluid added will increase the recovery time.
- Any one still residing or working in this area is requested to refrain from the use of sewer services. Contact the registration center for details on temporarily lavatory facilities.
- Area from McRorie Dr south through to Mile 5.
  - All infrastructure services online.
- Corridor Zone
  - No road access to Paradise Gardens. Road is closed.
  - Power distribution services are currently in place but may be disconnected at any time to allow electrical service inspection.
  - Mixed impact to services in other areas. Additional detail will be provided as available.
