## REPORT TO COUNCIL

**DEPARTMENT: Public Works DATE:** March 16,2022

**SUBJECT:** Fraser Place Tender Award

#### **RECOMMENDATION:**

THAT THE COUNCIL OF THE TOWN OF HAY RIVER Award the Fraser Place Tender to 5904 NWT LTD O/A Blackstone Homes for \$3,169,584.20.

#### BACKGROUND:

Fraser Place is a planned housing development for 29 - R1B zoned residential properties accessed off McBryan Drive.

The tender for Fraser Place construction included the clearing of trees and brush, underground infrastructure of water, sewer, storm sewer and local utilities, as well as roadways. Asphalt surfacing, sidewalk, curb and gutter are to be tendered separately, in accordance with the Town's 10 Year Capital Plan, for construction in a future year.

The Fraser Place construction project was tendered on February 11/22 with a closing date of March 9/22 and received 3 bids:

- 851791 NWT LTD o/a Rowe's Construction \$3,356,703.85
- Green Acre Ventures LTD \$3,832,595.00
- 5904 NWT LTD o/a Blackstone Homes \$3,169,584.20

Upon review of the submitted bids by Town administration and our engineering partner Stantec, and in consideration of Stantec's opinion of probable cost of \$3,601,449.25, it is recommended that the Fraser Place construction project be awarded to 5904 NWT Ltd. o/a Blackstone Homes.
