BACKGROUND:

The Hay River Marine Rescue Society (Coast Guard Auxiliary) has been servicing the Hay River area for over 30 years. They are a group of volunteers dedicated to helping people if they get into trouble on the water. The mandate of the Society is the assist any and all marine traffic that needs assistance, whether commercial fisherman or pleasure crafts.

The Hay River Marine Rescue Society is applying for funding to complete work on the former RCMP vessel, the “Mackenzie”. The vessel needs legs replaced, new sponsons and a paint job.
